979X's "TEXT TO WIN 979X PRESENTS ELECTRIC CITY ROCKS TICKETS" CONTEST OFFICIAL RULES

The Station will conduct the 979X's "Text to Win 979X Presents Electric City Rocks Tickets" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider.

4. Winner Selection. On or about 11:00am ET on Monday, April 29, 2024, Station will select FIVE (5) potential winners in a random drawing from among all valid entries received by Station during the Contest Period. Each winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules).
