## 979X'S "ENTER TO WIN: POCONO RACEWAY DRIVER JUMBLE" CONTEST OFFICIAL RULES

The Station will conduct the **979X's "Enter to Win: Pocono Raceway Driver Jumble**" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. All entries must be received by 11:59pm ET on Friday, June 13, 2025 to be eligible for a chance to win a prize. Limit one (1) entry per person per day, regardless of how many email addresses a person may possess and use. Multiple entrants are not permitted to share the same email address.
